The intent of the 5310 Enhanced Mobility of Seniors & Individuals with Disabilities program is to improve mobility for seniors and people with disabilities by providing financial support, through programs planned, designed, and carried out to meet the transportation needs of these populations.

The deadline for project application submission passed **December 31, 2020**.
